RULES AND REGULATIONS

1. Contestant must have reached her 18th birthday and have not reached her 27th birthday by December 31, 2008.
2. Contestant must be of good moral character.
3. Contestant must live in the area where this local preliminary is being held. (**Not applicable for 2008.**)
4. Contestant looks solely to the Regional Director with respect to all matters relating to preparation, rehearsal, performance, selection process and all other matters pertaining to the local competition. **THE MISS EARTH NEW ZEALAND CONTEST** is in no way liable for anything in regards to the local competition. (Applicable only where Regional Director has been assigned by Miss World New Zealand Ltd.)
5. Contestant agrees to attend the **MISS EARTH NEW ZEALAND CONTEST** if selected as the winner in a local contest **or** through mail-in entry, and further abides by all the required services, rules and regulations governing this competition.
6. Contestant agrees to be bound by the rules and regulations and the contestant's contract required by the **MISS EARTH NEW ZEALAND CONTEST**, should contestant be chosen as a National Finalist.
7. No person related to anyone within the National **MISS EARTH NEW ZEALAND CONTEST** office nor that of the regional competition may enter without express written consent.
8. Contestant may not be married, divorced, had a marriage annulled, nor be living husband-wife in a common-law marriage. Entrant may never have given birth to a child.
9. Contestant must attest that she was born a female.
10. Contestant must be a New Zealand citizen either by birth or naturalization and must provide proof of the foregoing.
11. Contestant understands that there is no cost (other than postage) for entering the mail in competition to be selected as a National Finalist for the **MISS EARTH NEW ZEALAND CONTEST 2008**. However, should contestant be accepted as a National Finalist, an entry fee will be charged. Further information on the Entry Fee is available from Miss World New Zealand Ltd.
